

## ESSENCE W+P Note di Pulito

### PRODUCT DESCRIPTION:

Highly concentrated essence with Note di Pulito scent for both laundry and dry cleaning.

### HOW TO USE:

**WATER:** Hygienfresh Essence has to be used in the last rinse, with a limited water level.

- Dosage: 1 – 3 ml of Hygienfresh Essence per Kg of dry garment, with machine fully loaded.

**PERC:** Hygienfresh Essence has to be used with machine fully loaded, preferably in the second bath, by dosing it in the bottom trap or with automatic dosage.

- Continuous distillation: 2 – 3 ml of Hygienfresh Essence per Kg of dry garment
- Manual distillation: 3 ml of Hygienfresh Essence per kg of garment during the first wash with clean solvent. 1 ml per Kg of garment in next washes without distillation.
